**ADMISSION PROCEDURE**

- The program is a compulsorily residential with the same fee structure for Management Quota and Government quota (including lapsed seats).
- This application will be considered for admission against lapsed seats in the Government Quota or vacancies that come across in Management Quota due to any withdrawals. Past experience indicates that there will be a few seats likely to be available under this category after the due date of reporting at the institution for Government Quota admissions.
- Applicants seeking admission to MBA program of **SSN School of Management (SSN SoM)** under **lapsed seats** should have taken any one of the following all India admission Tests and scored the respective percentiles as indicated.

**CAT / XAT / CMAT (conducted for 2024 admissions)  $\geq$  60 percentile**

**MAT 2023-24 (Sept / Dec 2023, Feb / May 2024)/ ATMA 2024  $\geq$  80 percentile**

**TANCET 2024  $\geq$  80 percentile**

**Any State Level Admission Tests (2024)  $\geq$  80 percentile**

- Calls for selection process will depend on the likelihood of lapsed seats in the Government Quota as on the last date of reporting at the institute.
- Candidates with less than 60% (or equivalent) in X / XII / UG or those who have more than 2 history of arrears in UG are requested **not to apply**. For candidates completing their UG in 2024, cumulative performance till the most recent semester will be considered for provisional admission. The final admission will be subject to them meeting the above criteria in the overall UG program.
- The candidates who do not have admission test scores as indicated above are requested **not to apply** for lapsed seats.



- The call for selection process will be based on past academic track record and performance in the entrance test. Past academic track record will also include history of arrears in the UG program. The call for selection process in case of candidates with one or two history of arrears is subject to the academic review by SSN and the institution reserves the right to call.
- The rank lists would consider **past academic record, entrance test scores, work experience, essay appreciation skills and performance at Interview to be held by us.** *Please note that SSN uses these entrance test scores as one of the bases for admissions. The institutions conducting the tests have no role in the admissions of SSN SoM.*
- Last date for receipt of completed applications form is not applicable. Candidates are advised to apply immediately.
- Applicants applied under management quota are requested **not to apply** under lapsed seats as their existing application will be considered for lapsed seats (for any vacancies).
- The mere filing of application form under lapsed seats category for admission to program or a call for GD/PI does not mean/ guarantee an admission to MBA Program 2024. The admission is granted subject to you performing well and qualifying for admission. In addition, these students need to wait for any lapsed seats.
